ABOUT RYT

For 37 years Riverland Youth Theatre has been making art with and for our community, empowering children and young people as artists, learners and doers.

Our artistic program includes:

- Weekly classes for ages 0-26 throughout the Riverland
- Online creative classes for children who cannot access our program in-person
- Professional development for artists & educators
- · School holiday programs
- Special projects
- Opportunities for parents/carers to interact creatively with their children

In 2022 our major projects performance projects were:

- Treetops and Towers, a performance entirely created in Minecraft
- Silent Discos, in Waikerie, Loxton, Barmera and Renmark
- A roadtrip to Adelaide wth our teens for workshops and performances with State Opera South Australia and Rumpus Theatre, a costume department tour of State Theatre Company South Australia
- Our holiday programs, including 3 Day Plays, making plays from scratch in three days
- A two-week development of our new production of War of the Worlds, coming 2024

In addition to artistic and creative opportunities, our tiny company provides well-being programs for vulnerable young people including the following:

- 3rd Place offering times for young people and adults to come together in our space without expectations or structured lessons
- Pondi our fortnightly Aboriginal Youth Group
- 1-2-1 mentoring, art and play for children and young people who thrive outside of group settings

In 2022 we ran major wellbeing projects Making Pride and There I Am, celebrating identity through costume design and craft. We also renewed our commitment to radical accessibility by hiring through disability employment schemes and welcoming Office Baby, Banjo, to ensure his mother Jenna could continue to excel in her work despite a chronic lack of childcare in our region, and Teenager In Residence, Rowen.

Riverland Youth Theatre stands on the lands of the First Peoples of the River Murray and Mallee. Our staff and board pay our respects to the Elders past, present and emerging of the Ngintait, Nganguruku, Erawirung, Ngawait, Ngarkat, Ngarlata and Ngaiwang peoples.

CHAIR CLINT BINDER

I am delighted to present RYT's Annual Report for 2022. I am an RYT Alumni of almost 30 years, and this is my first year as the Board's Chairperson. Thank you to the many new Board Members who have taken the reigns this year I am looking forward to all of the exciting new initiatives in the works.

Our Creative Director, Fleur Kilpatrick, has been the number one driving force behind our successes in the last year – delivering an intense and diverse calendar of events, programs and performances throughout the year. I am confident long as the Board provides Fleur with an adequate and sustainable amount of support, and a likeminded team of helpers, we will be able to maintain this intensity.

RYT's level of engagement with the community and partnerships with other organisations has increased dramatically. This has vastly improved our reputation in the community and has also allowed us to share our message more effectively within a greater social network.



We have also embraced new technology and modern methods of communication (ie. social media) to engage effectively with today's youth – again making sure our message is effectively distributed to the community.

It brings me great joy to see our youth numbers growing to levels we enjoyed in my past. Like so many youths in the Riverland, RYT was an essential part of my personal growth – giving confidence, an outlet for creativity and providing a safe place where I could be me. I am so happy that this will be the case for many future generations.

So... that was big!

2022 started small but ambitious. My title was 'Creative Producer', a title that means 'we used to be an artistic director AND a company manager but, after funding cuts... you get to be both!', and Molly was my 20-hour-aweek admin assistant, pregnant and throwing up in the bin under her desk.

There is a beauty to the smallness of organisations like ours. One of us would have an idea, the other would say "that's a good idea" and we would make it happen. After the bureaucracy of my previous work in universities, there was a lightness to this way of working but there was no denying that RYT was running on our adrenaline.

This is how regional artists get burnt out. This is how companies go through an artistic director every 18 months and I am acutely aware that the worst thing I could do for this community is burn out and leave. But the story of 2022 is really the story of how we went from a staff of 2 (well, 1.5 FTE) to a staff of 6 (well, 2.1 FTE) and, with each new addition to our team, we were able to clarify our vision and commitment to our values.

First came Alysha. We were thrilled to receive Variety SA's Sprout funding: \$50 000 a year for the next three years. With this funding we increased the hours for our administrator and created a new role and hired RYT Alumni Alysha Herrmann as our first Community and Digital Artist. Alysha runs a robust digital program as well as Home Turf, a school holiday program offered in Pinnaroo, Lameroo, Blanchetown, Waikerie and Morgan towns often left out of creative programs.

At the heart of Alysha's role is RYT's commitment to creating pathways for young regional people to find their People and their passions.

Then I was introduced to the disability employment scheme, subsidies, and our Games Master, Jay Green. Jay learnt fast when it came to admin and even faster when it came to dressing up in robes and pixie ears, but he found his calling when we met a boy, who could not attend regular school because, in his own words, "I kick and hit other children". The boy taught us an important lesson – Family Friendly Is Not Friendly For All Families – and Jay took that lesson and ran with it. With this role, we are working to make RYT a radically accessible safe space for neurodiverse children, those living with disabilities and carers.

One day I heard that Sage Wilde, an artist I had previously hired to run a few classes, was a client of the same disability support provider, WISE. I called up WISE and said, "can I have Sage too?" When I told my teen class that I had hired Sage, they screamed with delight. "They taught me sooooo much about autism that I DIDNT EVEN KNOW!" "I didn't know what masking was and they just made it all make SENSE!" Sage's lived knowledge of navigating the medical and mental health system as a non-binary person is invaluable to our young people. Sage is our Queer Support Captain and Producer of The Judys, our 18+ Queer group and P.O.T. LUCK storytelling nights. Their role is part of our ongoing commitment to advocacy for young queer people through a wholistic approach to arts and wellbeing a wholistic approach to arts and wellbeing.

After their initial funding ran out, I was able to cover their wage through project grants as they are such a multidisciplinary artist.

One day another disability employment provider, MOBO Employment Group, knocked on the office door, so I boiled the kettle and we started talking.

"How are you with trans people?" the woman asked.
"Hey Ro," I called to the trans teen reclining on the couch, "how are we with trans people, mate?" "Nah, we don't like people like me around here."

This new partnership with MOBO brought us Mel Donkins. Mel's arrival was a revelation. Mel is an I.T. professional, a skillset seldom available to a tiny country theatre company. Mel will announce "I've been watching the way you use the computer and I have some ideas for how to make everything run smoother" or shell say "hey, do you think any kids would like virtual reality?" (Um... YES) "I was wondering if you want a 3D printer in here?" (OF COURSE) (We now print custom fidget toys for participants and staff.) "Do you think any kids would like to take apart computers?" (YOURE A GENIUS) Mel's role – now partially funded by the Suzanne Elliot Charitable Trust – is all about our commitment to offering diverse and innovative program, guided by the passions, curiosities

For three months there we also had a venue technician, Alex Suchenko, working to maintain our beautiful home, The Renmark Institute, and make it a more functional space for our community to use.

While temporary, this role helped us facilitating collaboration with our local community and champion regional arts in our community because, if it is local, if it is joyful, if it is creative, if it empowers our community and makes the world less lonely and more accessible, we love it.

So welcome to our 2022 annual report: the story of a huge year of change for a tiny company, hitting well above our weight. As long as our community keeps telling us what they want, need and love and we'll keep making good things happen. Thank you for trusting us with your community, your funding, your support, your secrets, your families and your children. Thank you for trusting us to play and create with. Together we are making the Riverland more accessible, fun, welcoming and creative.

Everyone wins in new RYT lease changes

A RIVERLAND theatre organisation will pay minimal rent for its premises under changes to its lease agreement with a local council.

Renmark Paringa councillors passed a motion at last month's general meeting to endorse an amended lease with the Riverland Youth Theatre (RYT) regarding the Renmark Institute on Ral Ral Avenue.

ing the Renmark Institute on Ral Ral Avenue.

Under the new lease agreement — which runs for five years, with a five-year renewal term — council will be paid a peppercorn rent for the site, in lieu of RYT receiving \$5000 in annual funding through the Community Grants Policy.

RYT chairperson David Langdon said the amended terms provided the organisation with a "secure foundation for the years ahead".

"Renmark Paringa Council has been a key supporter and partner of RYT for many years and my board is grateful to have such a strong co-operative relationship with our local government and community." Mr Langdon said.

"Despite these difficult times, we look forward to an exciting period of reinventing artistic opportunities for children and young people.

"With our new creative producer, Fleur Kilpatrick, at the helm of our artistic programs, the future looks bright".

Mr Langdon said the Renmark Institute would still be made available for community military ceremonies, and the Riverland Rose and Garden Festival's annual display.

"The staff and board of RYT take pride in our responsibility as custodians of such

Youth theatre welcomes artist Alysha on board

A WELL-known local creative's new career path is set to help youth from the Riverland and Mallee enjoy improved access to arts

Riverland Youth Theatre (RYT) last week announced Alysha Herrmann had joined the company as digital and community artist.

RYT creative producer Fleur Kilpatrick said ensur-ing the organisation's pro-grams were accessible for kids throughout the Riverland and Mallee was a goal for herself and Ms Herrmann.

"How do we make what we do more accessible, and how do we create safe digital spaces for young people?" Ms Kilpatrick said.

"In addition to organisational fit, Alysha and I are very unified in what we think arts are for and who we think arts are for and who we think arts are for and who we think

"We want everyone to feel

like they are welcome in art, craft, and play. Alysha is driven in the same way I am to create spaces for the community."

Ms Kilpatrick said constructing an ongoing program of in-person and digital work-shops for Mallee youth would be a key focus of the new role.

"Alysha will be creating a program where we go to five different towns that would often be left off the map, and deliver a day of school holiday workshops," she said.

"That will commence from the summer holidays onwards, and these coming holidays we're going to do some community consultations in those

connected, creative, and keep playing with us while we're not physically there."

Ms Herrmann said digital programs would allow creative youths from the Riverland and Mallee to collaborate on arts

I've worked remotely as a creative producer, artist and writer for years," she said. "There's a lot of tools now

that people are feeling more equipped to use, but there hasn't necessarily been that same commitment to thinking about how young people access those tools.

"Access isn't just putting something online, it's thinking about the design and structure around it, and how people are welcomed into that space.

That approach to how we think about access, how we bring people into a space, and how we create those spaces to fit around the people who need them, is really core for me in this role."

Ms Kilpatrick said RYT was utilising popular video games such as Minecraft to host digital theatre events.

"At the moment we have a program happening all in Minecraft," she said. "A lot of kids already love

Minecraft... and the kids com-ing into that didn't necessarwant to make theatre, be an actor or a playwright. They are learning a lot about theatre as they do it, and they create a



Cosy Hangs was an event I held at Part of Things, partnered with RYT, where I built a pillow fort and four teens and myself just got to hang out, and get know each other. We shared music and talked about our hyperfixations, and things that happened in our pasts. It was such a beautiful bonding moment and we have held those connections beyond the event.



CHALLENGES

The low level of core funding received remains a significant challenge and a major limitation. There are rapidly increasing opportunities, requests and ideas and the need across our large region (three Local Government Areas) is enormous. Whilst we have good success with project grants, very few grants or programs exist to support our core budget. This means we continue to operate without a company manager, with only part-time administrative support and that our artistic director's wage is well below the national averages for youth theatre artistic directors. We continue to run on adrenaline, tiny grants, spend a lot of time on small acquittals.

Along with the joy of Molly's new baby, we also struggled with the shortfalls of country medical services. Baby Piper kept wanting to come early and Molly had to be rushed away to Adelaide with no notice for weeks at a time.





Growing as a company - from two to six employees in the space of six months - brought with it significant organisational challenges and required a shift in systems and practices. Where once everything had been a conversation between Fleur and Molly, now we required staff meetings, Fleur needed 'Quiet Time' for her easily distracted brain in an open plan office and we discovered how little we actually documented our constant conversations. More staff require more systems to ensure that the right information is reaching the right person. Such sudden growth has been a steep learning curve for us all.

We work hard to create safe spaces for our young people so, perhaps counter-intuitively, we know we're doing something right when kids don't mask around us: when they bounce off walls, talk non-stop about Pokémon, stim, tic, disclose things that are worrying them, cry or vent.

We've been asked to join children and families at school meetings and Fleur is an emergency contact for several kids because "if I need to leave school it will be because of anxiety and you're better at that than grandma."

Notes to the Financial Statements

Riverland Youth Theatre Inc For the year ended 31 December 2022

The financial statements cover Riverland Youth Theatre Inc as an individual entity. Riverland Youth Theatre Inc is a not-for-profit association incorporated in South Australia under the Associations Incorporation Act 1985 ('the Act')

Comparative are consistent with prior years, unless otherwise stated.

1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Act. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

The association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services renderedby employees to the end of the reporting period. Employee provisions have been measured at theamounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required to ettle the obligation at the end of the reporting period.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in theassets and liabilities statement.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
